2. In accordance with the provisions of Article XVI, paragraph 2, of the Convention, these amendments to Appendix III shall take effect 90 days after the date of this Notification, i.e. on 22 June 2021.
3. The CITES Secretariat also noticed that *Altiphrynoidea* spp. was incorrectly inserted in the Appendices after *Amietophrynus superciliaris*. When publishing the new version of the Appendices, the CITES Secretariat will place *Altiphrynoidea* spp. in the correct alphabetical order under Bufonidae.
4. The revised edition of the CITES Appendices will be placed on the CITES website before it enters into effect.
