Voor het op 19 Juni 1951 te Londen gesloten Verdrag tussen de Staten, die partij zijn bij het Noord-Atlantisch Verdrag nopens de rechtspositie van hun krijgsmachten zie tevens *Trb.* 1954, 81.

Voor het op 20 September 1951 te Ottawa gesloten Verdrag nopens de rechtspositie van de Noord-Atlantische Verdrags Organisatie, van de nationale vertegenwoordigers bij haar organen en van haar internationale staf zie tevens *Trb.* 1954, 82.

Voor het op 28 Augustus 1952 te Parijs ondertekende Protocol nopens de rechtspositie van internationale militaire hoofdkwartieren, ingesteld uit hoofde van het Noord-Atlantisch Verdrag, zie tevens *Trb.* 1953, 70 en 1954, 83.

- II. De Noord-Atlantische Raad heeft op 24 September 1953 een resolutie aangenomen, waarvan de tekst luidt als volgt:

RESOLUTION ON ASSISTANCE TO GREECE

The North Atlantic Council:

- (1) recalls its resolution of the 19th August expressing its sympathy with the Greek Government and people on the disastrous earthquake in the Ionian Islands;
- (2) notes with satisfaction the emergency relief measures undertaken by member nations of NATO to assist the Greek Government and people;
- (3) recognises that, in spite of the emergency relief given, there remains the problem of rehabilitation and reconstruction for the areas affected by the recent disaster and that such rehabilitation and reconstruction will place an added burden on the Greek Government and people who, by their present defence effort and past sacrifices, have already contributed so greatly to the security of the free world;
- (4) recalls the provisions of Article 2 of the Treaty whereby the member nations undertake to do their utmost to promote conditions of stability and well-being throughout the Alliance;
- (5) accordingly calls on the governments and peoples of the North Atlantic Alliance to contribute, to the best of their ability, and by such means as may be most appropriate, to the effort which the Greek Government itself is making to bring about the rapid rehabilitation of the devastated areas;
- (6) invites the member governments to consult with the Greek Government as to the most suitable form which their contribution should take, and to report to the North Atlantic Council the action taken, either through official or private channels, to give effect to this resolution.

- III. De Noord-Atlantische Raad heeft op 17 Februari 1954 een resolutie aangenomen, waarvan de tekst luidt als volgt:

**RESOLUTION ACCEPTING THE RELEASE OF ADMIRAL
LYNDE D. McCORMICK AND REQUESTING NOMINA-
TION OF A U.S. OFFICER TO BE HIS SUCCESSOR**

The North Atlantic Council,

Having noted with regret a communication by the President of the United States to the Secretary General and Vice-Chairman of the Council requesting him to initiate appropriate action to secure the early release of Admiral Lynde D. McCormick from assignment as Supreme Allied Commander Atlantic,

accepts with regret the necessity of the release of Admiral McCormick from assignment as Supreme Allied Commander Atlantic, effective on 12th April 1954 as requested by the President of the United States;

recognises the Admiral McCormick has fully discharged the trust reposed in him by the North Atlantic Council when in January 1952 the Council appointed him Supreme Allied Commander Atlantic;

expresses to Admiral McCormick in the name of the Governments represented on the Council lasting gratitude for the distinguished service rendered by him;

requests the President of the United States to nominate an officer of the Armed Forces of the United States for appointment by the Council as Supreme Allied Commander Atlantic to succeed Admiral McCormick.

- IV. De Noord-Atlantische Raad heeft eveneens op 17 Februari 1954 een resolutie aangenomen, waarvan de tekst luidt als volgt:

**RESOLUTION APPOINTING ADMIRAL JERAULD
WRIGHT AS SUCCESSOR TO ADMIRAL McCORMICK AS
SUPREME ALLIED COMMANDER ATLANTIC**

The North Atlantic Council,

Having requested the President of the United States to nominate an Officer of the United States to fill the position of Supreme Allied Commander Atlantic and the President of the United States having nominated Admiral Jerauld Wright,

the Council

declares that it reposes the greatest faith in Admiral Wright, and

appoints him Supreme Allied Commander Atlantic as successor to Admiral Lynde D. McCormick; this appointment to become effective on 12th April 1954.

- V. De Noord-Atlantische Raad heeft op 5 April 1954 een resolutie aangenomen, waarvan de tekst luidt als volgt:

„The North Atlantic Council expresses its profound regret at the public statements made by the Commander-in-Chief Central Europe on 27th March, 1954 and subsequently reiterated. These statements are contrary to the explicit and repeated declarations of policy issued by the Council under whose authority all NATO Commanders hold their appointments.”

- VI. De Noord-Atlantische Raad heeft op 23 April 1954 een resolutie aangenomen, waarvan de tekst luidt als volgt:

RESOLUTION ON POLITICAL CONSULTATION

The North Atlantic Council

Having regard to the obligations assumed by the Parties to the North Atlantic Treaty

Recognising

(A) that the security and unity of the Atlantic Community depend not only on collective defence measures but also on co-ordinated diplomatic policies; and

(B) that developments in the international situation affect each of the Parties;

Reaffirms the views of the Committee on the North Atlantic Community endorsed by the Eighth Session of the Council at Rome;

Agrees that the Council should be used when appropriate for exchanges of views on political questions of common concern;

Recommends

(A) that all member governments should bear constantly in mind the desirability of bringing to the attention of the Council information on international political developments whenever they are of concern to other members of the Council or to the Organisation as a whole; and

(B) that the Council in permanent session should from time to time consider what specific subject might be suitable for political consultation at one of its subsequent meetings when its members should be in a position to express the views of their governments on this subject.
