3. Invites the Parties concerned to note that, in accordance with article VIIIb(vii)2 of the Convention and article VI of the 1988 SOLAS Protocol, the amendments shall enter into force on 1 July 2006 upon their acceptance in accordance with paragraph 2 above;

###### *Surveys of structure, machinery and equipment of cargo ships*
