#### A. TITEL

Handelsovereenkomst tussen het Koninkrijk der Nederlanden en Bezet Japan, met bijlagen; Tokio, 13 April 1951.

#### B. TEKST

# Trade Agreement between the Kingdom of the Netherlands and Occupied Japan

The Representatives of the Kingdom of the Netherlands and the Representatives of the Supreme Commander for the Allied Powers acting in respect of Occupied Japan (hereinafter referred to as Japan), having discussed the measures which might usefully be adopted with the intention both of expanding trade between the Netherlands and Japan and of maintaining it at the highest volume practicable have agreed to adopt the following principles:

#### Article I

For the purpose of this Agreement the Kingdom of the Netherlands is understood to include the Netherlands, New Guinea, Surinam (Dutch Guyana) and the Netherlands Antilles.

#### Article II

- a. All trade except as otherwise provided shall be conducted in accordance with the terms and provisions of the "Financial Agreement for Trade between the Kingdom of the Netherlands and Occupied Japan", to be executed simultaneously herewith.
- b. Trade may be carried on through both governmental and private channels.

- c. A Trade Plan will be adopted extending to all transactions relating to the purchase and sale of goods and services in respect of which contracts are executed during the effective period of such Trade Plan.
- d. The Trade Plan, without being restrictive in any way, represents in the light of the best information available at the time to the two parties to this Agreement, the volume of trade which may be expected to flow between the Kingdom of the Netherlands and Japan for the duration of such Trade Plan and the character it is most likely to assume. The Trade Plan may be enlarged or amended by mutual consent at any time.

It is emphasized that the Trade Plan is not intended to constitute a commitment binding on either party that the trade will, in fact, attain the proportion or assume the character indicated therein; rather does it represent a reasonable computation made in good faith of the volume of sales and purchases likely to result from the desire of the two parties tot this Agreement to develop trade between them to the highest practicable level.

Subject to these considerations, both parties will facilitate in every way the sale and purchase of goods and services as set forth in the Trade Plan, and will do everything feasible to relax existing trade, currency and other controls which may have the effect of restricting trade between the two countries.

- e. Consistent with import, export, and exchange controls in effect, the Kingdom of the Netherlands agrees to permit the importation from and exportation to Japan, and Japan agrees to permit the importation from and exportation to the Kingdom of the Netherlands of commodities at least up to the amounts set forth in the Trade Plan.
- f. Each party hereto will do everything feasible to ensure compliance with the export-import controls, exchange controls and such other controls that pertain to international trade as may be in force and effect from time to time in the areas under the control of the other.
- g. Special machinery will be established in common accord to ensure that accurate and up-to-date information will be available to both parties in respect of the operation of this agreement and to ensure the implementation of the Trade Plan generally.
- h. Should there be reason for either party to this Agreement to believe, at any stage, that the volume and character of sales and purchases contemplated in the Trade Plan are not likely to materialize, they will consult together for the purpose of discussing remedial measures, or of effecting any modification of the Trade Plan that may be found necessary, and to ensure that such modification of the Trade Plan protects those interests to which either party attaches special importance.

i. In order to facilitate trade among the Kingdom of the Netherlands, Japan and third countries, the parties to this Agreement will consult as circumstances may require with respect to the possibility of developing trade on a multilateral basis.

#### Article III

The trading position between the Kingdom of the Netherlands and Japan shall be reviewed generally by the parties to this Agreement from time to time as requested by either party.

#### Article IV

This Agreement may be revised by mutual consent of the parties or cancelled upon request of the Representatives of the Kingdom of the Netherlands or of the Supreme Commander for the Allied Powers, or his successor, upon ninety (90) days' notice in writing and shall terminate unless the parties hereto stipulate in writing to the contrary on the proclamation of a peace treaty between the Allied Powers, or any of them, and Japan. Any revision, cancellation or termination of this Agreement shall be without prejudice to any right or obligation accruing or incurred hereunder prior to the effective date of such revision, cancellation or termination.

#### Article V

This Agreement shall become effective upon execution by both parties.

Done in Tokyo, Japan in duplicate on the 13th day of April 1951.

The Trade Plan (attached as Tab A) sets forth the estimates of the commodities and services to be interchanged between the Kingdom of the Netherlands and Occupied Japan on the basis of contracts for procurement of commodities and services executed during the period 1 January 1951 to and including 31 December 1951.
- 2. The attached Trade Plan is adopted in accordance with the terms and provisions of the Trade Agreement between the Kingdom

of the Netherlands and Occupied Japan to be executed simultaneously herewith.
