### F. TOETREDING

Op grond van artikel XVI is IJsland op 4 Juni 1952 toegetreden tot de onderhavige Overeenkomst en tot het sub J. afgedrukte Protocol. De akte van toetreding luidt:

"The undersigned, duly authorized, declares that:

The Government of Iceland

Having considered the Agreement on North Atlantic Ocean Weather Stations, signed in London on 12 May 1949, and the Protocol for extending the period of the said Agreement, signed in Montreal on 28 May 1952, and

Having offered to make a token contribution in cash of one thousand pounds Sterling (£ 1,000) per annum, commencing with the year 1951, such offer having been accepted by Council on the sixteenth of May 1952,

Hereby accedes to the said Agreement as modified by the said Protocol, and

Undertakes to make, on the terms of and subject to the conditions of the Agreement as amended, a token contribution in cash of one thousand pounds Sterling (£ 1,000) per annum, commencing with the year 1951.

Done in Montreal on the fourth day of the month of June of the year nineteen hundred and fifty-two.

Op 28 Mei 1952 is te Montreal een Protocol ondertekend, waarbij de geldigheidsduur van de Overeenkomst met een jaar is verlengd.

De Engelse tekst van dit Protocol luidt:

### **Protocol**

# extending the period of the Agreement on North Atlantic Ocean Weather Stations signed in London on 12 May 1949

Whereas the Council of the International Civil Aviation Organization recommended, on 7 December 1951, to the Governments signatory of the Agreement on North Atlantic Ocean Weather Stations signed at London on 12 May 1949

(a) that the conference to be convened by the Council not later than 1 October 1952, pursuant to Article XVII (2) of the said Agreement, to consider the revision and renewal of the Agreement, be postponed for a period of approximately one year;

(b) that, consequently, the operation of the North Atlantic Ocean Weather Stations, in accordance with the terms of the said

Agreement, be extended for a period of one year; and

Whereas all the signatory Governments have notified their concurrence in the abovementioned Council's recommendations;

The undersigned representatives, appointed by their Governments for this purpose, have agreed as follows:

### Article 1

The Agreement on North Atlantic Ocean Weather Stations signed at London on 12 May 1949 which, pursuant to Article XVII (1) of the said Agreement, should have been terminated on 30 June 1953, shall remain in effect until 30 June 1954.

### Article 2

The Council shall convene, not later than 1 October 1953, the Conference which would have been convened pursuant to Article XVII (2) of the Agreement, not later than 1 October 1952, for the purpose of considering the revision and renewal of the said Agreement.

### Article 3

This Protocol shall come into force on the date of its signature.

In witness whereof, the undersigned, being duly authorized thereto, have affixed their signatures on behalf of their respective Governments.

Done in Montreal, the twenty-eighth day of the month of May of the year nineteen hundred and fifty-two, in the English, French and Spanish languages, in a single copy open for signature at that date which shall be deposited in the Archives of the International Civil Aviation Organization. Certified copies thereof shall be transmitted by the Secretary General of the Organization to all signatory Governments.

Het Protocol is door Denemarken ondertekend onder het volgende voorbehoud:

"The Danish Government wishes to state that the reservation made by Denmark on the ratification of the Agreement is still valid, namely, that the Agreement on North Atlantic Ocean Weather Stations will cease to bind the Danish Government if the Agreement concluded in Montreal on 9 September 1949 between the Danish Government and the Council of ICAO regarding certain Air Navigation Services in Greenland and the Faroe Islands becomes void. Furthermore, the Danish Government wishes to state, as a presupposition for its signature, that the negotiations regarding the contributions toward the new services at the Station Prins Christianssund will soon lead to a result satisfactory to Denmark."
