A. TITEL

Handelsovereenkomst tussen het Koninkrijk der Nederlanden en de Staat Israël, met bijlagen; Jeruzalem, 11 oktober 1957

B. TEKST

Trade Agreement between the Kingdom of the Netherlands and the State of Israel

The Government of the Kingdom of the Netherlands and the Government of Israel wishing to maintain and develop trade relations between the Kingdom of the Netherlands and the State of Israel have agreed as follows:

Article I

The Government of the Kingdom of the Netherlands and the Government of Israel will grant each other the most favourable treatment possible in reciprocal authorization of imports and exports.

Article II

(a) The Government of the Kingdom of the Netherlands undertakes to authorize the export of the commodities indicated in List A attached to the present Agreement.

The Government of Israel undertakes to authorize the import of the said commodities.

(b) The Government of Israel undertakes to authorize the export of the commodities indicated in List B attached to the present Agreement.

The Government of the Kingdom of the Netherlands undertakes to authorize the import of the said commodities.

Article III

All payments for commodities, services and other operations will be governed by the stipulations set out in the Payments Agreement between the Kingdom of the Netherlands and the State of Israel signed this day.

Article IV

With a view to extending trade relations between the two countries the Government of the Kingdom of the Netherlands and the Israel Government will duly examine the possibilities of authorizing private compensation transactions under the present Agreement. Licences can be granted only by common accord between the competent authorities of the countries concerned. It is well understood that care will be taken to avoid market disturbances.

Article V

A Joint Commission consisting of representatives of the two Governments will survey the application of the present Agreement, exchange periodically information regarding imports and exports of commodities between the two countries and, when necessary, proceed to the revision of the Lists A and B.

The Joint Commission will make recommendations with a view to facilitating the exchange of goods as well as to furthering the economic and financial relations.

The Joint Commission wil be convened at the request of either of the two parties.

Article VI

For the purpose of this Agreement the Kingdom of the Netherlands is understood to include the Netherlands New Guinea, Surinam (Dutch Guyana) and the Netherlands Antilles.

The application of this Agreement to Surinam and the Netherlands Antilles is subject to the approval of their respective governments, which approval shall be understood to have been given unless the Netherlands Government, within three months of the signing of this Agreement, has notified the Government of Israel of the non-participation of the Governments of Surinam and/or the Netherlands Antilles.

Article VII

Should the Governments of the Netherlands, Belgium and Luxemburg decide upon a common foreign trade policy as regards the State of Israel, the Contracting Parties agree to discuss as soon as possible any modifications of the present Agreement which may become necessary.

Article VIII

The letters No. I, Ia, II, IIa, III and IIIa attached hereto form an integral part of the present Agreement.

Article IX

The present Agreement enters into force on the date of its signature with retroactive effect as from 1 May 1957, and will be valid for one year until 30 April 1958. It supersedes the Trade Agreement cum Annexes signed on 27 June 1955 and the Protocol cum Annexes signed on 13 September 1956.

If neither Party gives notice of its intention to terminate the Agreement three months before 30 April 1958, the Agreement will be renewed for a period of one year and for additional periods of one year, unless either Contracting Party will have given such notice three months before the end of the respective year of the Agreement.

In witness whereof the undersigned, duly authorized to that effect, have signed the present Agreement.

Letter No. III

Jerusalem, 8 May 1957

Mr. Chairman,

I am glad to confirm that in the course of the negotiations leading up to the Trade Agreement initialled to-day the following was agreed upon:

- 1. Both Contracting Parties agree to refrain from discriminatory action and unnecessary restrictions affecting shipping engaged in international trade.
- 2. In the event of the coming into force of a multilateral agreement aiming at the removal of discriminatory action and unnecessary restrictions affecting shipping engaged in international trade, to which the Contracting Governments are parties, the provisions of the foregoing paragraph shall be regarded as having been superseded by the provisions of such multilateral agreement.
- 3. At the request of either of the Contracting Parties, officials of the two Governments shall meet in order to determine whether the shipment of goods by sea between the two countries has been carried on in accordance with the principles of non-discrimination between their two flags and to take such measures as may be necessary with a view to avoiding any difficulties that may arise.

G. INWERKINGTREDING

De bepalingen van de Overeenkomst zijn ingevolge artikel IX, eerste lid, op 11 oktober 1957 in werking getreden, en wel met terugwerkende kracht van 1 mei 1957 af, voor een periode van één jaar, welke periode ingevolge artikel IX, lid 2, stilzwijgend kan worden verlengd telkens voor één jaar.

De toepassing van de Övereenkomst op Suriname en de Nederlandse Antillen is ingevolge artikel VI, lid 2, onderworpen aan de goedkeuring van de Regeringen van die landen, welke goedkeuring geacht zal worden stilzwijgend te zijn verleend, indien de Nederlandse Regering niet vóór 11 januari 1958 van het tegendeel zal hebben kennisgegeven aan de Regering van Israël.
