Op 17 februari 1962 zijn te 's-Gravenhage tussen de Nederlandse en de Finse Regering nota's gewisseld, strekkende tot buitenwerkingstellering, per 1 januari 1962, van de onderhavige Overeenkomst.

De tekst der nota's luidt als volgt:

The Hague, February 17th, 1962.

Your Excellency,

Considering that the provisions of the Payments Agreement between the Republic of Finland and the Kingdom of the Netherlands, signed

in The Hague on June 29th, 1955, no longer apply, the Finnish Government is of the opinion that it would be in the interest of both the Contracting Parties to the Agreement that it be invalidated.

If the Netherlands Government agrees, I am instructed by my Government to propose that the present letter and Your Excellency's reply, should it be in the affirmative, abrogate the said Payments Agreement as from January 1st, 1962.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
