In overeenstemming met artikel 60, lid 2, der Grondwet is de overeenkomst vervat in de op 26 september 1961 te Canberra tussen de Nederlandse en Australische Regering gewisselde nota's (tekst in rubriek J van *Trb.* 1961, 141) medegedeeld aan de Eerste en de Tweede Kamer der Staten-Generaal bij brieven van 8 januari 1962 (Bijl. Hand. II 1961/62 — 6600, nr. 1).

Op 29 en 31 maart 1962 zijn te Canberra tussen de Nederlandse en de Australische Regering nota's gewisseld tot verlenging van de

werkingsduur van de Overeenkomst voor het tijdvak van 1 april tot 1 oktober 1962.

De tekst van deze nota's luidt als volgt:

EMBASSY OF THE NETHERLANDS

Canberra, 29th March, 1962.

Sir,

I have the honour to refer to the exchange of Notes which took place on 26th September, 1961, between representatives of our two Governments on the question of the extension of the Assisted Migration Agreement between the Government of the Commonwealth of Australia and the Government of the Kingdom of the Netherlands.

The said Agreement was signed on the 1st of August, 1956, and was operative for a period of five years from the 1st of April, 1956, expiring on the 31st of March, 1961.

Pending completion of a new Agreement, it gives me pleasure to inform you that the Government of the Kingdom of the Netherlands is prepared to agree to a further extension of the validity of the old agreement from the 1st April, 1962 to 1st October, 1962.

If the foregoing is acceptable to your Government, I have the honour to propose that this Note and your confirmatory reply thereto be deemed to constitute and be evidence of the extension of the agreement.
