Wat het Koninkrijk der Nederlanden betreft, geldt de Overeenkomst voor het gehele Koninkrijk.

H. TOEPASSELIJKVERKLARING

In tegenstelling tot het in rubriek H van *Trb.* 1970, 178 gestelde is de Overeenkomst in overeenstemming met artikel 9, eerste lid, per 1 december 1970 uitgebreid tot Suriname en de Nederlandse Antillen door middel van een op 7 oktober 1970 te Kingston tot stand gekomen notawisseling tussen de Regering van het Koninkrijk der Nederlanden en de Regering van Jamaica. De tekst van deze nota's luidt als volgt:

Excellency,

With reference to the Agreement between the Government of the Kingdom of Belgium, the Government of the Grand Duchy of Luxembourg and the Government of the Kingdom of the Netherlands on the one hand, and the Government of Jamaica on the other on the abolition of visas, signed at Kingston on October 7, 1970, and further to my note of April 21, 1970, No. 412, I have the honour to propose Your Excellency that the application of the Visa Abolition Agreement in accordance with its article 9 shall be extended to Surinam and the Netherlands Antilles.

If the proposal is acceptable to the Government of Jamaica, I have the honour to propose further that the present letter and your reply concurring therein should be considered as an agreement between the Government of the Kingdom of the Netherlands and the Government of Jamaica with respect to this matter, which agreement will enter into force on the same date as the Visa Abolition Agreement.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
