Tijdens de van 8 tot 12 mei 1972 te Londen gehouden Tiende Bijeenkomst van de Visserijcommissie voor het noordoostelijk deel van de Atlantische Oceaan is een aantal aanbevelingen vastgesteld,

welke in de Nederlandse wetgeving zullen worden verwerkt. De Engelse tekst van deze aanbevelingen luidt als volgt <sup>1)</sup>:

#### **North Sea Herring (Recommendation (8))**

The Commission made a Recommendation to provide an alternative to the regulation on closed seasons for herring during 1973 which is contained in Recommendation (8) as made at the Extraordinary Meeting of the Commission held from 9th to 11th December, 1971.

The text is as follows: -

- "(a) Notwithstanding the provisions in paragraphs 1, 2 and 5 of this Recommendation a Contracting State shall have the right as far as 1973 is concerned to catch herring for human consumption or bait in the period 1st February to 31st March up to a limit of its catch for those purposes in those months in any of the years 1969 to 1972. If the right is exercised the amount of 2,500 tons exempted in the paragraphs 2 and 5 shall be reduced to 1,250 tons for the remaining period of the closed season.
- (b) The Commission should, before 1st January 1973, be notified by the competent authority of a Contracting State about the exemption alternative chosen by that State."

#### **Attachments to Nets**

The Commission agreed to amend Recommendation (3) (b) so as to extend its currency until 31st December 1975. Recommendation (3) (b) permits Contracting States to authorise the attachment of specified chafers or covers to the upper side of the cod-ends of trawl nets for the purpose of preventing wear or tear.

#### **Areas Closed to trawling in the Bay of Biscay**

The Commission agreed to amend Recommendation (9) so as to extend its currency until 31st December 1973. Recommendation (9) prohibits fishing by trawl in two areas of the Bay of Biscay.
