Op 29 maart en 14 april 1976 zijn te Canberra tussen de Nederlandse en de Australische Regering „letters of understanding” inzake de toepassing van het Verdrag gewisseld.

De tekst van deze „letters of understanding” luidt als volgt:

The Royal Netherlands Embassy presents its compliments to the Department of Foreign Affairs and has the honour, with reference to the recent exchange of Notes on the subject between the Embassy and the Department, to inform the latter that the Government of the Kingdom of The Netherlands considers that the Treaty between the United Kingdom of Great Britain and Ireland and the Kingdom of The Netherlands for the mutual surrender of fugitive criminals, signed in London on September 26, 1898, which Treaty created certain rights and obligations for the Commonwealth of Australia at a time when it was a territory under the sovereign jurisdiction of the United Kingdom, has continued without interruption to be binding upon the Commonwealth of Australia and the Kingdom of The Netherlands.

It would be appreciated if the Department would confirm that the foregoing is the understanding of the Government of the Commonwealth of Australia.

The Royal Netherlands Embassy avails itself of this opportunity to renew to the Department of Foreign Affairs the assurances of its highest consideration.
