Sir,

I have the honour to give you below the text of arrangements between the United Nations and the Government of the Netherlands (hereinafter referred to as "the Government") in connexion with the ad hoc Meeting on New Concepts in the Layout of Urban Districts and the Design and Management of Traffic Therein of the Economic Commission for Europe, to be convened at the invitation of the Government, in Veldhoven from 4 to 7 May 1981.

"ARRANGEMENTS BETWEEN THE GOVERNMENT OF THE NETHERLANDS AND THE UNITED NATIONS REGARDING THE AD HOC MEETING ON NEW CONCEPTS IN THE LAYOUT OF URBAN DISTRICTS AND THE DESIGN AND MANAGEMENT OF TRAFFIC THEREIN OF THE ECONOMIC COMMISSION FOR EUROPE, TO BE CONVENED IN VELDHOVEN FROM 4 TO 7 MAY 1981.

1. Participants in the meeting will be invited by the Executive Secretary of the United Nations Economic Commission for Europe in accordance with the rules of procedure of the Commission and its subsidiary organs.
2. The Government shall impose no impediment to transit to and from the meeting of any persons whose presence at the meeting is authorized by the United Nations and shall grant any visas required for such person's promptly and without charge. The Convention of 13 February 1946 on the Privileges and Immunities of the United Nations, to which the Netherlands is a party, shall apply.

Financial arrangements

3(a) In accordance with the United Nations General Assembly Resolution A/RES/31/140 paragraph 3, adopted by the General Assembly on 17 December 1976, the Government will assume responsibility for any supplementary expenses resulting directly or indirectly from holding the meeting at Veldhoven rather than at the United Nations Office at Geneva. Such costs, which are provisionally estimated at approximately 3,500 United States dollars shall include, but shall not be restricted to, the actual additional costs of travel and of staff entitlements of the United Nations officials assigned to attend the meeting as well as the costs of shipment of meeting documentation to and from Veldhoven. Arrangements for such travel and shipment shall be made by the secretariat in accordance with the Staff Regulations and Rules of the United Nations and its related administrative practices in regard to travel standards, baggage allowance, subsistence payments (per diem) and terminal expenses. Official telephone and telex charges covering traffic from the meeting site will be the responsibility of the Government.

(b) The Government shall, not later than 15 April 1981, deposit with the United Nations the sum of 3,500 United States dollars, representing the total estimated costs referred to in paragraph (a) above. This deposit should be paid wholly in United States dollars by a bank transfer to Lloyds Bank International, 1 Place Bel-Air, 1211 Geneva 11, Switzerland, to UN Geneva General Fund No. 4, for credit to account No. 183547-01-10, quoting the title and dates of the meeting for which this advance payment is being made.

(c) If necessary, the Government shall make further advances as requested by the United Nations so that the latter will not at any time have to finance temporarily from its cash resources the extra costs that are the responsibility of the Government.

(d) The deposit referred to in paragraph (b) above shall be used only to pay the obligations of the United Nations in respect of the meeting.

(e) After the meeting is over, the United Nations shall give the Government a detailed set of accounts showing the actual additional costs incurred by the United Nations as a result of holding the meeting at Veldhoven rather than at the United Nations office at Geneva, which shall be borne by the Government pursuant to paragraph (a) above. These costs shall be expressed in United Nations dollars using the United Nations official rate of exchange in effect at the time the payments were made. The United Nations, on the basis of this detailed set of accounts, will refund to the Government any funds unspent out of the deposit referred to in paragraph (b) above. Should the actual additional costs exceed the deposits, the Government will remit the outstanding balance within one month of the receipt of the detailed accounts. The final accounts shall be subject to audit as provided in the Financial Regulations and Rules of the United Nations, and the final adjustment of accounts shall be subject to any observations which may arise from the audit carried out by the Board of Auditors.

4. The Government will provide for the meeting adequate facilities including personnel resources, space and office supplies as described in the attached annex.

5. The Government shall be responsible for dealing with any actions, claims or other demands which may be brought against the United Nations for damages to facilities used in the course of the meeting, for damage or injury to persons or property caused to third parties, or arising out of the employment of local personnel, and shall hold the United Nations and their officials harmless in respect of any such actions, claims or other demands.

6. The rooms, offices and related localities and facilities put at the disposal of the meeting by the Government shall be the meeting area, which shall constitute United Nations premises within the meaning of Article II, Section 3, of the Convention of 13 February 1946.

7. The Government shall notify the local authorities of the convening of the meeting and request appropriate protection."

I have the honour to propose that this letter and your affirmative answer shall constitute an agreement between the United Nations and the Government of the Netherlands which shall enter into force on the

date of your reply and shall remain in force for the duration of the meeting and for such additional period as is necessary for its preparation and winding up.

FACILITIES AND RESOURCES TO BE PROVIDED BY THE GOVERNMENT OF THE NETHERLANDS IN CONNEXION WITH THE AD HOC MEETING ON NEW CONCEPTS IN THE LAYOUT OF URBAN DISTRICTS AND THE DESIGN AND MANAGEMENT OF TRAFFIC THEREIN, 1981

I. Space

- A Conference room with equipment for simultaneous interpretation in English, French and Russian and a seating capacity of 50 persons with microphones (with a standard equal to that of the Palais des Nations in Geneva), to be provided at the meeting place.
- Three offices for ECE secretariat to be provided at the meeting place.
- Offices for local staff, for reproduction of documents, typing, etc. at the meeting place.

II. Office supplies

- The following equipment to be provided at the meeting place:

- in addition to the usual office supplies, two electric typewriters, with English (QWERTY) keyboards;
- equipment for the projection of films, slides and charts;
- blackboard;
- reproduction equipment for conference room documents.

III. *Local staff*

- A liaison officer responsible for organizational arrangements, including the preparatory period.
- A receptionist for registration of participants, supply of information, and distribution of documents during the meeting.
- A reproduction unit for the duplication of documents issued during the meeting.
- An English typist.

IV. *Attendance of United Nations personnel, travel costs and other expenses*

- Three staff members of the Economic Commission for Europe.
- Six interpreters (English/French/Russian).
- Travel costs Geneva-Veldhoven-Geneva, subsistence and terminal expenses of two professional staff members, one documentation officer and six interpreters.
- Cost of shipment of documents and equipment by air Geneva-Veldhoven-Geneva.
- Expenses connected with the utilization of the telecopier link with Geneva, including communications, installation charges.

Wat het Koninkrijk der Nederlanden betreft, geldt de overeenkomst alleen voor Nederland.

J. GEGEVENS

Van het op 26 juni 1945 te San Francisco tot stand gekomen Handvest der Verenigde Naties zijn de Franse en de Engelse tekst, zoals gewijzigd, geplaatst in *Trb.* 1979, 37; zie ook *Trb.* 1980, 41.

Van het op 13 februari 1946 te Londen tot stand gekomen Verdrag nopens de voorrechten en immuniteten van de Verenigde Naties, naar welk Verdrag wordt verwezen in de paragrafen 2 en 6 van de onderha-

vige brieven, zijn tekst en vertaling geplaatst in *Stb.* I 224; zie ook, laatstelijk, *Trb.* 1979, 35.

Voorts is bij briefwisseling tussen de Regering van het Koninkrijk der Nederlanden en de Verenigde Naties het volgende overeengekomen:

“It is understood that immunity of jurisdiction does not apply to road offences committed by a privileged person, nor to cases of damage caused by a motor vehicle belonging to or driven by such a person.”.
