De tekst van de Overeenkomst, alsmede een vertaling in het Frans daarvan, is afgedrukt in „*Recueil des Traités*” der Verenigde Naties, deel 646, blz. 117 e.v.

De Bijlage bij de Overeenkomst is in overeenstemming met artikel 10 van de Overeenkomst gewijzigd bij notawisseling van 7 april en 13 december 1983.

De tekst van de nota's luidt als volgt:

The Royal Netherlands Embassy presents its compliments to the Ministry of External Affairs of the Republic of Trinidad & Tobago and has the honour to refer to discussions which were held at Willemstad, Curaçao on July 21 and 22, 1981, between delegations of the Republic of Trinidad & Tobago and of the Netherlands Antilles on a modification of Section I of the route schedule in the Annex to the Agreement between the Government of the Kingdom of the Netherlands and the Government of the Republic of Trinidad & Tobago for the establishment and operation of air services, concluded at The Hague on July 3rd, 1967.

In accordance with the provisions of Article 10 of the abovementioned Agreement, the Embassy would like to inform the Ministry, that the Government of the Kingdom of the Netherlands herewith confirms the modification of Route I of Section I of the Annex to the Agreement agreed upon between the two delegations, which will read as follows:
