Verklaringen, voorbehouden en bezwaren

Azerbeidzjan, 2 december 2008

In accordance with Article 24, paragraph 1, of the Convention, the Republic of Azerbaijan declares that it will be unable to guarantee compliance with the provisions of the Convention in its territories occupied by the Republic of Armenia until these territories are liberated from that occupation.

Azerbeidzjan, 15 februari 2010

The Republic of Azerbaijan declares that it is unable to guarantee implementation of the provisions of the Convention in its territories occupied by the Republic of Armenia (the Nagorno Karabakh region of the Republic of Azerbaijan and its seven districts surrounding that region), until the liberation of these territories from the occupation and complete elimination of the consequences of that occupation (the schematic map of the occupied territories of the Republic of Azerbaijan is enclosed here).

The occupying power - the Republic of Armenia shall bear all responsibility for destroying architectural heritage in the occupied territories of the Republic of Azerbaijan as from the date of the occupation until the liberation of those territories from the occupation and complete elimination of the consequences of that occupation.

Denemarken, 23 juli 1987

The Convention shall not apply to the Faroe Islands not to Greenland.

Frankrijk, 17 maart 1987

In accordance with Article 24, paragraph 1 of the Convention, the Government of the French Republic declares that the Convention shall apply to the European Departments and to the overseas Departments of the Republic.

Griekenland, 7 juli 1994

The Government of the Hellenic Republic declares that the accession of the Former Yugoslav Republic of Macedonia to the Conventions of the Council of Europe to which the Hellenic Republic is a Contracting Party does not imply the recognition of the Former Yugoslav Republic of Macedonia by the Hellenic Republic.

Ierland, 20 januari 1997

In accordance with Article 25, Ireland declares that it reserves the right not to comply with the provisions of paragraph 2.c of Article 4 of the Convention.

Nederlanden, het Koninkrijk der, 15 februari 1994

The Kingdom of the Netherlands declares, in accordance with Article 25, paragraph 1, of the Convention, that it reserves the right not to comply, in whole, with the provisions of Article 4, paragraphs 2c and 2d.

Nederlanden, het Koninkrijk der, 28 september 2010

The Kingdom of the Netherlands currently consists of three parts : the Netherlands, the Netherlands Antilles and Aruba. The Netherlands Antilles consists of the islands of Curaçao, Sint Maarten, Bonaire, Sint Eustatius and Saba.

With effect from 10 October 2010, the Netherlands Antilles will cease to exist as a part of the Kingdom of the Netherlands. From that date onwards, the Kingdom will consist of four parts: the Netherlands, Aruba, Curaçao and Sint Maarten. Curaçao and Sint Maarten will enjoy internal self-government within the Kingdom, as Aruba and, up to 10 October 2010, the Netherlands Antilles do.

These changes constitute a modification of the internal constitutional relations within the Kingdom of the Netherlands. The Kingdom of the Netherlands will accordingly remain the subject of international law with which agreements are concluded. The modification of the structure of the Kingdom will therefore not affect the validity of the international agreements ratified by the Kingdom for the Netherlands Antilles: these agreements, including any reservations made, will continue to apply to Curaçao and Sint Maarten.

The other islands that have until now formed part of the Netherlands Antilles - Bonaire, Sint Eustatius and Saba - will become parts of the Netherlands, thus constituting “the Caribbean part of the Netherlands“. The agreements that now apply to the Netherlands Antilles will also continue to apply to these islands; however, the Government of the Netherlands will now be responsible for implementing these agreements.

In addition, a number of the agreements that currently apply to the Netherlands are hereby declared applicable, from 10 October 2010, to this Caribbean part of the Netherlands.

Oostenrijk, 3 oktober 1985

The Republic of Austria, according to Article 25, paragraph 1 of the Convention for the Protection of the Architectural Heritage of Europe, declares that it reserves the right not to comply in whole with the provisions of Article 4, paragraphs c) and d).

Slowakije, 7 maart 2001

The Slovak Republic, in accordance with Article 25, paragraph 1, of the Convention for the Protection of the Architectural Heritage of Europe, declares that it reserves the right not to comply with the provisions of sub-paragraph 2. d of Article 4 of the Convention concerning the compulsory purchase of a protected property.

Verenigd Koninkrijk, het, 13 november 1987

In accordance with the provisions of Article 25(1), the United Kingdom states that Article 4(c) of the Convention cannot at present apply to Northern Ireland.
